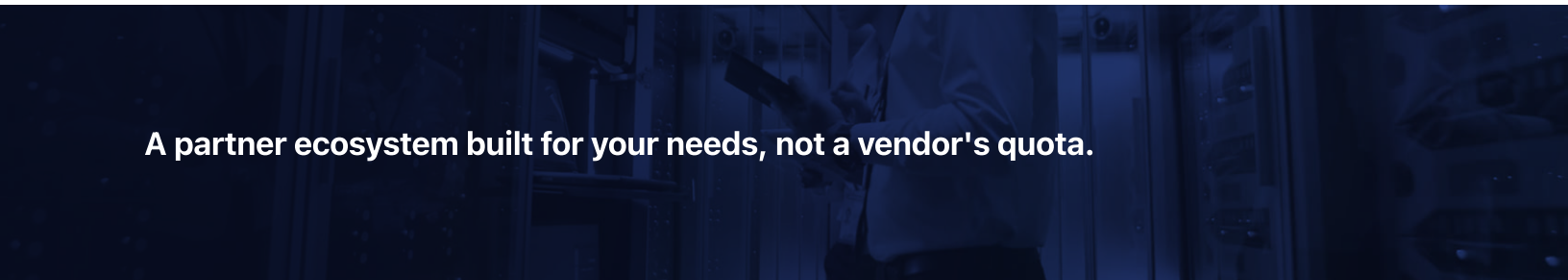

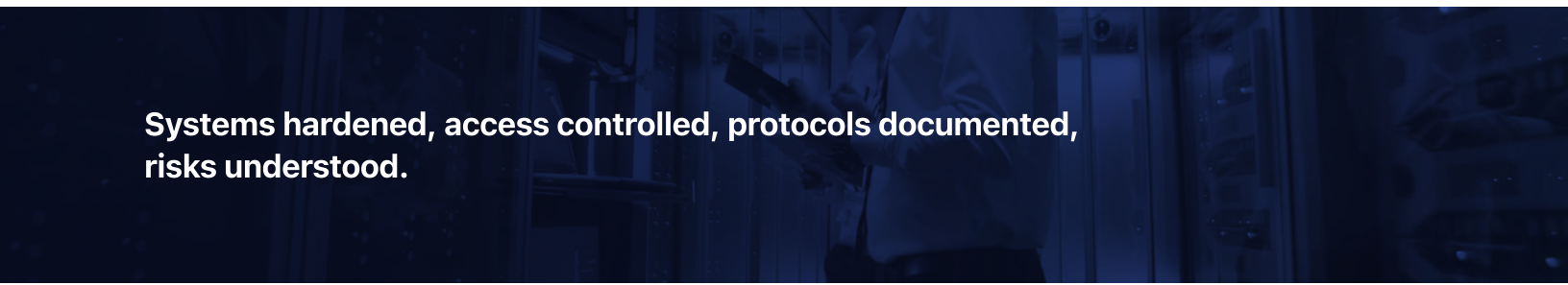

In addition, BryTech continues to support ongoing training requirements for customer staff and provides knowledge transfer and transition tasks with customer management personnel.

Mission Control Center virtualization

BryTech was subcontracted to Lockheed Martin (now Leidos) for \$8.5M to support the Facilities Development and Operations Contract (FDOC) for Johnson Space Center's Mission Operations Directorate, which includes mission control, mission planning, reconfiguration, and training systems.

BryTech worked with Lockheed Martin and NASA to propose and implement a highly virtualized environment for the Mission Control Center for the 21st Century (MCC21). To support MCC21, BryTech designed and deployed an environment leveraging virtualization technology from IBM including backend servers and storage, and the "blue screen" terminals were replaced by virtual desktop infrastructure (VDI) workstations. For the first time, MCC21 is completely hardware, vendor, and location independent.
